It has been my great privilege and pleasure to care for you during my past 33+ years of practice. I have approached our relationship with respect and responsibility, and hope I have cared for you capably and compassionately.

Effective April 1, 2016, I am transitioning my practice into Colorado Allergy & Asthma Centers, P.C. (CAAC), colleagues with whom I have worked for many years, and several of whom are good friends. They are an excellent group of physicians and support staff with 10 locations in the Denver Metro area, soon to be 11 with our Greenwood Medical Center office, which I started over 33 years ago. Your medical records will continue to be maintained at the Greenwood office in the future. I shall also devote more time to the Holocaust Genocide Contemporary Bioethics Program at the Center for Bioethics and Humanities at CU, which I helped establish.
