Calls during business hours;

- **Medical question or need to be seen that day:**
Call and press 3. This is the appointment line that directly connects you to our staff.
- **Medical question that is NOT urgent:** Call and press 2 (non-urgent message for call back). You may leave a message and a return call will be made to you within 24 hours.
- **Pharmacy Requests** are only received during business hours .Contact your pharmacy and the pharmacy will contact us to complete your refill. Please allow 24 hours for refill requests.

Calling After business hours:

- **Call 911 for life threatening episode**
- **Medical question that is urgent; 8am-10pm** a provider is available
- **Pharmacy Requests ;** Call pharmacy

School forms: You may mail, fax or drop off school forms to the office. Please complete as much information as possible. Allow a minimum of 48 hours for completion of school forms. Provide the necessary phone and fax numbers if the form is to be faxed. **An office visit with a provider in the past year is needed to obtain school forms.**

Work forms: You may mail, fax or drop off work forms to the office. Complete information on the form as much as possible. Allow one week for completion. A fee may apply.

A yearly office visit is recommended for follow up to review your medications and treatment plan.
