99202	Office or other outpatient visit for the evaluation and management of a new patient, which requires medically appropriate history and/or examination and straightforward medical decision making. When using time code selection, 15-29 minutes of total time is spent on the date of the encounter	\$155.36
99203	Office or other outpatient visit for the evaluation and management of a new patient, which requires medically appropriate history and/or examination and low level of medical decision making. When using time for code selection, 30-44 minutes of total time is spent on the date of the encounter.	\$241.60
99204	Office or other outpatient visit for the evaluation and management of a new patient, which requires medically appropriate history and/or examination and moderate level of medical decision making. When using time for code selection, 45-59 minutes total time is present on the date of the encounter	\$336.86
99212	Office or other outpatient visit for the evaluation and management of an established patient, which requires medically appropriate history or examination / or examination and straightforward medical decision making. When using time for code selection, 10-19 minutes of total time is spent on the date of the encounter.	\$122.96
99213	Office or other outpatient visit for the evaluation and management of an established patient, which requires medically appropriate history or examination and low level of medical decision. When using time for code selection, 20-29 minutes of total time is spent on the date of the encounter.	\$196.36

<b>95004</b>	Percutaneous tests (scratch, puncture, prick) with allergenic extracts, immediate type reaction, including test interpretation and report, specify number of tests.	\$7.60/test
<b>95024</b>	Intracutaneous (intradermal) tests with allergenic extracts, immediate type reaction, including test interpretation and report, specify number of tests.	\$16.12/test
<b>94010</b>	Spirometry, including graphic record, total and timed vital capacity, expiratory flow rate measurement(s), with or without maximal voluntary ventilation.	\$55.08
<b>94375</b>	Respiratory flow volume loop.	\$88.14
<b>95115</b>	Professional services for allergen immunotherapy not including provision of allergenic extracts; single injection.	\$21.84
<b>95117</b>	Professional services for allergen immunotherapy not including provision of allergenic extracts; 2 or more injections.	\$26.10
